

Charter of the IMSG

To facilitate collective and global efforts on issues related to the MEMS industry that ... are more appropriately undertaken as an international industry association ..., among which are:

- -1. To acquire and disseminate market information and statistics about IMSG activities ...
- -2. To achieve better representation in regard to legislation and lobbying efforts concerning the MEMS industry.
- -3. To promote customer awareness of the technical, regulatory, and business issues facing the MEMS industry in meeting customer expectations in product quality and value.
- -4. To promote and support cooperative and global efforts between the International MEMS Steering Group members and other SEMI member companies to solve common problems and eliminate duplication of resources.
- -5. To promote awareness in the global SEMI organization of the expectations of the International MEMS Steering Group members and of the international MEMS industry
- -6. To promote participation in the SEMI International Standards Program for MEMS-related issues and to promote user awareness about SEMI standards.
- -7. To be involved in planning and/or sponsoring activities for SEMI exhibits, technical meetings, seminars and other SEMI events connected with the MEMS industry.
- -8. To receive SEMI support for meetings with MEMS industry leaders to discuss future trends and needs.
- 2 -9. To create a forum to discuss safety and environmental issues.

 - Develop a focused "MEMS Message" to SEMI, IMSG members and their customers
 - Determine current membership needs
 - Maximize resource returns
 - Integrate NANO activities into the IMSG on all levels
 - Prioritize product/service development in line with needs of current membership
 - Provide a process for effective bi-annual planning and membership feedback
 - Provide a method measuring results and make course corrections as necessary
